The requirements for the type and placement of the extinguishers are as follows:

- 1. At least one portable fire extinguisher shall be installed in all one and two family dwellings (except seasonal rental units) upon change of occupancy
- 2. The extinguisher shall be listed, labeled, charged and operable
- 3. The weight shall be no more than 10 lbs for residential use and ABC Rated
- 4. The hangers or brackets supplied by the manufacturer must be used and the extinguisher must be mounted
- 5. The extinguisher must be located within 10 feet of the kitchen area
- 6. The top of the extinguisher must not be more than 5 feet above the floor
- 7. The extinguisher must be visible and in a readily accessible location, free from being blocked by furniture, storage or other items
- 8. The extinguisher must be near a room exit or travel path that provides an escape route to the exterior
- 9. The extinguisher must be accompanied by an owner's manual or written information regarding the operation, inspection and maintenance of the extinguisher
- 10. Lastly, the extinguisher must be installed with the operating instructions clearly visible.

The extinguisher shall be serviced and tagged by a certified Division of Fire Safety contractor within the past 12 months or the seller must have a receipt for a recently purchased extinguisher.

Ten year sealed battery-powered single station smoke alarms shall be installed and shall be listed in accordance with ANSI/UL 217, incorporated herein by reference. However, A/C powered single or multi-station smoke alarms installed as part of the original construction or rehabilitation project shall not be replaced with battery-powered smoke alarms. *The effective date of this subsection shall be January 1, 2019.

Specifications and installation instructions must be present for the inspection.
